John Albert (Jack) Maybee is President of the Maybee Society and makes the decisions regarding the Society including coordinating the family branches and their reunions. He is always searching for new members and for ways to improve the Society. In January, Jack also will be sending out welcoming letters to new members.

He says, "regarding my work years and a biography; I graduated from Canton H. S. in 1946 with an academic diploma; I graduated from Canton Tech in 1950. After four years in the Air Force (1950-1954) and three years married to Mary Ellen, I got my B.S. in mathematics and my M Ed from St. Lawrence University in 1956 and 1957. I taught Math for two years at Vestal, New York and was a guidance counselor in Rushville, New York and then Mary got me a job at the State Ed. Dept. in Albany where I retired in 1988! I've been living off the fat of the land ever since!

I started in genealogy in 1963 when my two aunts, Laura Gilmour and Mildred McKenny were disgusted because they didn't know who their own grandfather was! We found him in Watertown at the County Clerk's office; 1850 and 1855 Census; and then much later I found my mother's great grandfather, Thomas Buffham in the 1860 Census in Branch Co. Michigan. Now I have done a Gallagher book, a McCrea book and last year, a Buffham book, revised this past Sept. No more books, but lots of work on the computer on all the families!"

BARBARA MAYBEE CARTER

As Executive Secretary of the Maybee Society, I send out the Maybee Communicator, forward queries, input written genealogical information into our Master Genealogist data base, keep member records, and do other basic secretarial and accounting duties.

I have worked for most of my life in secretarial jobs and in positions as an Employment Aide or Nutrition Aide. My most recent job (1999) was as a Program Assistant in Employment for the YWCA's Pathways for Women division. I have also been part owner and operator of Victoria Catering.

STEVEN W. (STEVE) MABIE.

Steve Mabie, Member #257 continually searches for all Mabie/Maybee, et al records. He sends the results of his labors, census, church, military and other records and information on family lines to the Society each month. Several of his articles are in this newsletter and other information can be found on the Maybee Society website and at Steve's website.



Stephen W. (Steve) Mabie lives in San Antonio, Texas. He and wife, Nancy, have 5 children He was born in Philadelphia, Pennsylvania in 1947; is an 8th generation descendant of Jan Pieterse Mabee of Schenectady.

He has B.S. and M.S. degrees from Midwestern State University in Mathematics. He served 4 years in the US Air Force (Staff Sergeant) and 11 Years in Civil Service (Armaments Engineer, GM-14) at Picatinney Arsenal in New Jersey.

He was VP for 4 years of a small engineering company in New Jersey; has spent 11 years (and counting) as a consultant specializing in the resolution of contract disputes.

Genealogy interest was started by Royal Mabee in the 1960s. His major genealogy research began in 1997. He has put together a collection of wills, church records, civil records, military records, and census records for the entire Mabie/Mabee/Maybee/Mabey (etc.) family and has accumulated (so far) copies of approximately 100 wills, 1200 church baptism and marriage records, transcriptions of all census data (1790 - 1850), and perhaps an additional 300 civil marriage records. He has documentation on military service from the Revolutionary War and Civil War for just about every Mabie (etc.) who served and many from the War of 1812.

JOHN MAY BEE



John MayBee, Member #8 has agreed to coordinate our genealogical information. (See instructions at end of newsletter.)

.John was introduced to genealogy by his grandmother in the 1950s, but the interest lay fallow through a twenty-year career in the U. S. Navy. In the 70s his sister Belva (MS#2) asked him to research their father's mother's line. Starting like many another amateur he collected, and believed, any information given to him by any source. Slowly he learned to document his findings, analyze the data, and to push against the walls that appear in everyone's search for their families' roots.

John was able to reliably trace this line to William Backhouse born about 1615 in Swillington, England. He then traced the descendants of this man through the years and wrote a book about the branch that immigrated to America, *The Backhouse-Yorks of Montana*. He has been working the Maybee line intermittently for many years, even visiting the walled city of Naarden in the Netherlands only to find no records were kept of the common people, only of wars and nobility (and very little of that). Since he retired from manufacturing quality assurance, he has been putting more of his time into genealogy.

John joined Steve Mabie and Skip Duett in wrestling with the problem of the two (later three) Jan Pieters, helping them document that line. He and Steve delved into the mystery of the ancestry of the Jan Pieter Mabie who married Dorothy Pikkert (John's direct line). Steve found much of the basic information, and John played devil's advocate, until the preponderance of evidence showed that this Jan Pieter was probably the illegitimate son of the Pieter Mabie who married Susanna Vedder, and the grandson of the Jan Pieterse Mabie, with whom he was earlier confused. John now is entering the data researched and documented by Steve Mabie into the Maybee Society. He said. "Steve must wear a big 'S' on his chest! He is a super genealogist, as it is a full time occupation just transcribing the information he is collecting. He must work 24/7 just on the Mabie line"

BRET PERRY

Bret Perry, Member #86, is the son of Robert and Belva Perry. His interest in genealogy stems from helping his mother with the Maybee Society. Bret is our Internet coordinator. He and brother, Byron, have put together (and paid for) many software programs and hardware systems for us. They also lend their expertise to their aunt, who is a technophobe.

CHARLES W. GORTON

HENRY MAYBEE, MUSICIAN

"One last 'note' about Henry Maybee, musician: Captain Wilkes tried to put an orchestra together before leaving port and asked how many on his ship could play an instrument and a few claimed to be able to play the bugle, horn or clarinet but when they attempted to exhibit their skills the noise they produced was so dissonant that the captain gave up the idea of having an orchestra and was just happy to have a few men aboard such as Henry who could play either the fiddle or the banjo

The ship that Henry was on, the Peacock, was referred to by one writer as being the "Show Boat" of the little fleet and when it stopped to entertain the Indians along their route, the Indians would marvel that anybody could get such sounds out of what they referred to as "the little box". To add to the entertainment, the sailors would dance to the tunes coming from 'the little box', causing the Indians to believe that there was a devil in the box, which made the men act so strangely. The fiddlers even allowed the Indians could find no devil they concluded that the white man's devil was invisible.

The crew of the Peacock formed a cast of players to perform various short plays for the crews of

the fleet as well as the Indians they met along the way. One such play was Schiller's "Robbers", which the natives seemed to enjoy even though they complained about the play having too much talk, although the murders in the drama delighted them. The natives also laughed at the men in the play who attempted to act out the female roles.

In Sidney, the little squadron decided to give a grand ball for all who wished to attend. Governor Gibbs consented to having the ball at Fort MacQuarie and loaned out the regimental band for the occasion. The British colonial band arrived dressed in full uniform and hundreds attended the affair. The ball began with the British band playing "Rule Britannia" and the Yankees responded with fiddle and banjo playing "The Star Spangled Banner". After a few more national tunes the bands took turns providing music for minuets, polkas, reels, jigs, sword dances and hornpipes. The dancing lasted until dawn. The Governor and his lady led off several of the dances which were familiar to them.

Perhaps this is where Henry became smitten with one of the lovely ladies of Australia."

FOLLOW UP ON ADAM MABEE STORY

Steve Mabie sent the following information:

"This is a follow up to the article in the most recent Communicator (July 2000) that may provide some additional information on Adam Mabee and his family.

Adam Mabee (as his name was spelled in his will) was the son of Henrich Mabee and wife, Catherine. Adam was baptized in the Reformed Church, Gallatin,

Columbia County, NY, on November 15, Columbia County, NY, on November 15, 1777. Two other children of Henrich and Catherine were also baptized in this same church: Jeremiah

on March 21, 1779 and Jacob on February 25, 1781. Catherine's maiden name is uncertain, since the spelling in these three records vary: Weber, Wever and Weaver. Note that he is quite a different Henry than the one who was married to Anna Van Kat. I will provide more details on the two different Henry's if anyone is interested.

Adam married Anna Boyce on August 10, 1800 in the First Reformed Church of Tarrytown, NY (The Old Dutch Church of Sleepy Hollow), and on October 4, 1801, they baptized a son Henry (born August 27th) in the same church. While I have not been able to find records of the baptisms of any of their other children, Adam's will and the associated probate documents provide further details.

The Last Will and Testament of Adam Mabee of White Plains, Westchester County, New York, who died October 16, 1830, was written on January 21, 1830, and probated on February 8, 1831. Adam's will mentions by name only his wife Ann and his son Thomas, with references to other unnamed children, with the implication that at least some of the other children were under 21 at the time the will was written. On November 27, 1830, Thomas B. Mabee, of the City and County of New York, filed a petition with the Surrogate of the County of Westchester, specifically naming the heirs of Adam Mabee as his widow Ann, the petitioner Thomas, and Henry Mabee, Clarissa Mabee, Chauncey Mabee, Ann Eliza Mabee and Edmund Mabee.

Is it possible that the first wife of Adam's son Henry was named Sarah Berlisle? I ask only because a Henry Mabee married Sarah on July 27, 1828 in New York City. "

COURT-MARTIAL OF SIMON MABEE

Court Martial on Simon Mabee. [Miscel. Pap. 37: 383,387.]

Proceedings of a General Court Martial held by order of the Honourable Brigadier General McDougall, April 11th 1777.
Col. PHILLIP VAN CORTLANDT, President.
Col. Hooker, Capt. Pearcy, Capt. Sheppard, Col. Wiessenfells, Capt. Wright, Capt. Bray, Lt. Col. Renier, Capt. Smith, Capt. Johnson, Capt. Riker, Capt. Titus, Capt. Camp, Capt. Ben. Walker, Judge Advocate.

Simon Mabee was brought before the Court and Charged with being Employed by the Enemy as a Spy & for Enlisting men into their Service. The Prisoner on his Arraignment Plead Not Guilty.

Abraham Van Wert being sworn deposeth that he had the Command of a Scout about the Ist April that he went to the House of one John Hunt near the White Plains, that suspecting some Tories were there they surrounded the House & the Evidence went in with three Men to search, that they found a Man hid betwene a Feather & a Straw Bed. The Evidence does not know the man but thinks bis name was Fredick Phillipse, that they searched him & found about some Oranges, Tea & some Buckles. They then searched farther & in a back room found the Prisoner, brought him out searched him & found about him a silver Dollar and some Paper money. The Evidence then sent Alex. Fagen and another man to search the room where they found the Prisoner, that Fagen brought out Fifteen Dollars in Silver, a Warrent & Certificate.

The Warrant & Certificate being produced in Court are in the following words Viz.:

Whereas his Excellancy Sir William Howe Commander in Chief &c. &c. &c. has issued orders to Augment his Corps of Guides and Axmen under the Command of Major Holland Surveyor General of the Northern District of North America. This is therefore to certify that Simon Mabee is authorized and Empowered by me to engage Men for the said Service at the allowence of one shilling sterling p Day and their Provision Gratis to be discharged if desirous at the Expiration of the ensuing or next campaign. NEW YORK. March 30th SAMUEL HOLLAND.

I do hereby Certify that Simon Mabie of the Malitia of the City of New York has in my presence voluntarily taken an oath to bear Faith & true allegiance to his Majesty King George the third and to defend to the utmost of his Power his sacred Person, Crown & Government against all persons whatsoever. Given under my hand at New York this 29th Day of March in the seventeenth year of his Majestys Reign Anno Dom 1777.

The Evidence cannot possitively swear that the Warrent now produced in Court is the same but is certain it was nearly in the same words the Certificate produced the Evidence thinks it is the same that Fagen brought out - the Evidence thinks the Prisoner appeared to be frightened when he was taken - the Evidence knows Hunt at whose house the Prisoner was taken & says he bore the Character of a Tory.

Alex. Fagen being sworn says that he was ordered to go into the House to search that he found the Prisoner in a back room where they put their Meat, that he brought him out and gave him in Costody of the Guard, that he was ordered back to search the room which he did & found some hard money hid under a soap barrel and in a barrel betwene two pieces of Pork he found some Papers he did not read them but gave them to Abraham Van Wert who Commanded the Party. That Ab. Van Wert having Dropped some of the Money the Prisoner told him there was Fifteen Dollars & two Shillings. The Evidence says he knew the Prisoner before & his name is Simon Mabee. The Prisoner asking the Evidence if the money was not counted in his the Prisoners presence, the Evidence says it was. The Prisoner in his Defence absolutely denies knowing anything of the Papers that were found & says that there is a Simon Mabee who lived in Duchess County and has been gone from home some time, that himself is a Labouring Man, that he worked last summer on Long Island, that he had money due him and went there for it & returned two or three days before he was taken and was then on his way to his Fathers near Croton Bridge, that he has never taken up arms against the Country, that the reason of his hiding in the back room was because he was afraid of being taken up for having been on Long Island.

Mary Putnam being sworn says she is Sister to the Prisoner that she has a Nephew named Simon Mabee who has been missing near a year, she does not know where he is, that the Prisoner has no wife or family.

The Court having Considered the Evidence for and against the Prisoner, are of opinion That the Prisoner is Guilty of being Employed by the Enemy for the purpose of Inlisting Men into their Service & Consequently of being a Spy and therefore do sentence him to be hanged by the Neck untill he is Dead.

HEAD QUARTERS, PEEKSKILL, April 14th

GENTLEMEN: I have the honor to inclose you the sentence of a General Court Martial held at this Post on Simon Mabee by virtue of your late Resolution. The Prisoner confessed to me his having taken protection and that he knew the printed certificate from the Mayor copied in the proceedings. But denied his having seen the Warrant before I produced it to him and yet does not admit the former on his Trial.

When he was brought before me he had great appearance of Guilt in his countenance, which is a faithful Index to the Heart. He is a man of some cunning from his deportment and I have no doubt in my own mind of his being the man mentioned in the Warrant. This if handed to you by Express, whatever your determanation may be I wish to be favoured with it as soon as possible. He will wait a day for it. There are several small Houses in the Mountains which serve as rendevous and hiding places for the recruits & spies of the Enemy. The Safety of the Community in my opinion requires the Families to be removed and the Houses to be destroyed. The Barn of the Chairman of the Sub Committee for this Ouarter was set on fire at night three days ago, from the time and circumstances of it I am perswaded it was done by some Enemy to the Country. I wish to be possessed, of all the resolutions which inflict Death on the subjects of this State passed, by its Representatives. I have the Honor to be Gentlemen,

Your humble Servant, ALEX. McDOUGAL. The Honorable Convention.

OUERY ABOUT SARAH PIETERSE

Charles Stoodley sends the following query, "I am prompted to submit a query about my ancestor #3413 Sarah Pieterse (surname?) who married, probably in New Amsterdam/NYRDC, about 1646 a NA/NYC taverner (among other occupations), named Jan Jansen Schepmoes, from Delft in Holland, the Netherlands. Early

Maybee, et al researchers suggested that my Sarah Pieterse was the older sister of our Jan Pieterse Mabie, also sister of Jan's (proved) ancestor Engeltje Pieterse Mabie. This seems unlikely. However, has some recent research provided the parents ancestry of my Sarah Pieterse?"

He says that he had promised Belva to write an article on suggestions for abbreviations already standardized by the NYGB Record (1932?). He says that the abbreviated titles are still too long and has suggestions for shorter ones. He would like your opinions.

We have already implemented one suggestion he and Tyrone Tillson had for the newsletter. Newsletters will now have both the Issue number and page number on each page. This will make it easier to refile issues.

UPDATES AND CHANGES:

NEW MAYBEE SOCIETY DATABASE AND GEDCOM FILES

The Maybee Society has upgraded its database from Personal Ancestor File to run under The Master Genealogist program. TMG gives us better control of documenting sources and putting in additional events other than the birth, death, marriage and burial entries of PAF, and still gives us the ability to output Temple Ready files for the LDS Church.

The new downloadable GedCom on the Maybee Society website (available January 1, 2001) contains all the new work of Steve Mabie (#257), John MayBee (#8), and our President, John A. Maybee's South Valley File. The new file has 19,662 individuals in it, which are divided into 54 family groups. [There are no living people listed, and details on others are omitted at the request of the submitter.]

The largest group is descendants of

Pieter Casparszen van Naarden and

Aechie Jan van Norden. There are 12,755 people in this group and 172 Maybee Society members trace their lines in this file. The next largest family group is the Van Orden line, which, thanks to Maile Ho, traces its lineage from French Royalty. There are 4200 people in the main Van Orden line, and 22 people in the line of Frank Fatio Gibson III(#252), which

starts with David Van Orden (1813-1875) and his wife, Rachel.

We have nine groups of **English Mabeys** consisting of 327 people in nine family groups.

The next largest group is the descendants of **Jeremiah Mabie (1808-1877) who married Lois Evans** (-1856). There are 172 people in this group representing members, Thomas Lee Bryant # 49, Merry Helen Mabie #109, Sylvester Maxon Mabie #110, Miriam Ione Hoy #153, Edward Arthur Briggs #196, and Jeannine Mabie #198. The only other group of more than a hundred people is the 132 descendants of

John Maybee (1800-1866) This family was recorded by Anna Marie Stroda Jarboe, #71 and Ardene Maybee Galutia, #167

The Master Genealogist, along with the ability to document where each individual bit of data came from will greatly help us add your information to our master data set without loss. This program, through its GenBridge, will accept data directly from the following programs, without the loss of information that sometimes occurs in a GEDCOM transfer

DUES FOR 2001:

Donations to the Memorial fund for Belva in 1999 and the fact that she and husband, Bob Perry, had stockpiled such things as paper, envelopes and printer cartridges (many at their own expense) made it so that it was not necessary to raise the dues until now.

However, the increased cost of postage and the necessity to replace some equipment have made it necessary to make some changes in membership dues.

To remedy the problem we are doing two things; first we are offering the newsletter on website, (which costs less in costs for paper, envelopes and postage) for \$8.00 a year (see separate article) and also raising the dues for the printed newsletter to \$15.00 a year, EXCEPT for those who have already paid their dues for 2001.

We realize that it is difficult to remember whether you have paid dues for the year, since we don't send receipts. The code on your envelope will let you know whether your dues are up to date or not.

NEW SERVICES:

We are now offering an online Society Membership for \$8.00 a year. From newsletter articles you could put together a biography and pictures with material of your own for a family history. Also, many of the records that we receive which are too long to post in the paper version of the newsletter would be available to you.

If this is your choice for the way you would like to receive your newsletter, indicate it and send your email address when you send your dues, then the password will be sent to you.
