The President's Corner

Twenty-five years ago my sister Belva Maybee Perry, following in our grandmother's footsteps, was doing her own family genealogy. She had been corresponding with many people all over the United States, and became pen pals with many of them. In 1986 she and George Maybee Martin floated the idea of the Maybee Society and 33 people started the Society.

At that time there was no internet and these people were digging into family histories and bibles; looking into older publications that had information on our families, and into census records, church records; and government vital statistics.

Belva put the information from the submitted family group sheets, pedigree sheets and other paper records on index cards. In 1988 Belva moved this information to a computer. The card file was put in an early database and the family group and pedigree sheets were put into the new Personal Ancestry Files (PAF) put out by the LDS Church. Since that time, we have moved to newer and better programs and ongoing research has been able to untangle many (but not all) of the errors in original files. Where there our is

insufficient proof, we have made notes indicating differing opinions.

The work done by genealogical researchers prior to the internet was arduous involving much travel, mail inquiries, photocopying, etc. and we are very grateful for our predecessor's work. Now the internet gives us access to more and more original records to verify and add to our Maybee database, but we still need <u>you</u> to send in the data on your families that we do not have.



Research Update

The subjects of this edition's research update are Simon Mabee of Westchester County, NY, and how synergism plays a major role in advancing the genealogical research of our family.

But first, a little background on Simon and the rest of the family of Caspar Mabie, born in 1660. As most of you know, Caspar married

Lysbeth Schurmans on December 14, 1687 in the New York Dutch Reformed Church. We know they had the following children, all baptized in the same church on the dates noted: Peter (12/26/1689); Christine (6/30/1692); Fredrick (9/1/1695); Jeremias (6/25/1699); Abraham (11/18/1705); and John (5/9/1708). We also know, from the 1715 will of Sophia Romeyn (Lysbeth's aunt) that Caspar and Lysbeth had three other daughters whose baptism records have not been found: Affie, Sophia and Catherine.

We also know that Caspar and Lysbeth moved quite often, and that they lived in New York City, Harlem, Bergen County, NJ, and finally, New Rochelle, West Chester County, where Lysbeth's parents are known to have lived.

This brings us to Simon Mabee. We know that on 4/17/1724, Simon Mabe was listed as a Freeholder of New Rochelle. We also know that Simon and his wife Marie baptized two children in the French Church of New Rochelle: Elizabeth (4/17/1726) and Daniel (8/6/1732). The next definitive record we have for Simon Mabee is not until 1773, when on March 22, Simon Mabee of Courtlandt's Manor (Westchester County) ran an advertisement for a runaway slave named Ned in the New York Gazette and Weekly Mercury. From these few facts we

have been left to piece together the family and life of Simon Mabee.

Luckily, we have detailed information on the families and lives of Caspar's other children. We know that Peter, Caspar's eldest, married and baptized a large family in Bergen County. We know that John, after marrying and having a first child in New Rochelle, joined his brother Peter in Bergen County. Their families are well recorded in church records. Likewise, we know that Abraham baptized all his children in New Rochelle, and then moved on to Dutchess (later Putnam) County. And Jeremias married three times and baptized all of his children in the Dutch Church at Sleepy Hollow.

That leaves Fredrick, of whom there is absolutely no trace in any records. Thus we are left with tantalizing, but unanswerable questions. Is it possible that Simon Mabee is actually the child whose baptism record gives the name Fredrick? Or did Fredrick simply die unmarried? Or, if not, is it possible that Fredrick survived childhood, married, and had children? Unfortunately, given the state of the records in Westchester County, the answer to all of the above questions is yes.

However, all genealogists to date have assumed that Fredrick died without offspring, and that Simon Mabee was simply another child of Caspar, and that all other Mabees in Westchester County who appear in the time frame of a next generation are, in fact, offspring of Simon.

The first clue as to the names of Simon's sons comes in the form of a 1760 Muster Roll for Captain Ananais Rogers' Company of Westchester County Militia, whose members were from the area of Westchester County that included Courtlandt Manor. This list includes the names: John, Jacob, Jeremiah, Frederick, William and Symon Mabee (with various spellings of the surname). We can unambiguously establish that none of these men (who had to be between the ages of 16 and 60) were a son of either of Caspar's sons Abraham or Jeremias. Furthermore, none could possibly be a son of Simon's son Daniel, baptized in 1733. Therefore, at a minimum, we can establish that Simon was the father of 5 other sons: John, Jacob, Jeremiah, Frederick and William. Another possible son of Simon was Peter Mabee, who first shows up on Dutchess County Tax Rolls in 1763, was married to Elenor and who later moved to Saratoga. Peter was killed in the service of the British army during the Revolution. Most genealogists also credit Simon with three other children by a second marriage: Leah, Margaret and Silas. However, for these three, the possibility exists that these are children of Simon's son Daniel.

Finally, there is the case of a younger Simon Mabee, who was captured in 1777 and accused of spying for the British. After a court martial, Simon was hanged. During his trial, a witness in his defense was Mary Putnam, who claimed to be his sister, and who stated that he had no wife or family. At his trial, Simon stated that his father's farm was near Croton Bridge.

Enter serendipity. I recently became acquainted with a very capable researcher by the name of Gayle Ann Livecchia. Gayle is actively researching the Service/Servis Family, and my great-great-great grandfather, Peter Mabee, married Margaret Service, so I also am researching that family. Gayle was recently in New York City, at the New York Historical Society, doing research on the Service Family. One of the sets of documents she became interested in was the Papers of Sir Peter Warren. Sir Peter and his wife, Susan, were major land owners in colonial New York. both in what is now Montgomery County and in Westchester County. What Gayle found, among other things, was a detailed map of the Warren's holdings in Westchester County together with Rent Roll lists which named the tenants who resided on the land

Knowing that I would be interested in anything associated with the Mabie name, Gayle copied these documents and sent them to me. And now, for the first time, we have a surveyor's map (see next page, bottom of map) that shows exactly where Simon Mabee lived on the Croton River!

The map shows that Simon's lot, Lot #2, as 196 acres on the North side of the Croton River. The adjacent lot of 211 acres (Lot #1) was occupied by David Montross, with both of those lots abutting the Croton. On the other side of Simon was Richard Crab on Lot #15.


Interestingly, the corresponding list of tenants shows the acreage of the Montross and Mabee lots reversed, with Simon's being 211 acres, and Montross with 196. Based simply on looking at the map, I believe that the Tenant list is the more accurate, since Lot 2 appears on the map to be slightly larger than Lot 1.

The Rent Roll, dated 1769, also states that Simon was on "Parole" indicating in this instance that he no longer had to make rent payments to the Lady Susan Warren of 15 Pounds, 16 Shillings, presumably because he was of advanced age.

Space prevents me from attempting to include a copy of the Rent Roll as a part of this article, but I assure you it is fascinating to read all of the names of the tenants of Susan Warren in 1769. If anyone would like a copy of the jpg image (thanks to Gayle) I will be more than glad to e-mail you a copy separately.
