His final transfer was to Vestal, NY it was then that he decided to call Vestal his home. In Vestal, he managed the Hyster Lift Truck Division. During his tenure with SSC in Vestal he assisted with the layout and design of the Hyster Lift Truck Division in Conklin, NY. John retired from SSC after 25 years of service. John continued his professional career in Vestal, NY with Albany Ladder AKA South Central Scaffolding, NES, and currently United Rental for another 25 years. He finally retired in 2005.

John then became a regular spectator at all of his grandchildren's extracurricular activities. He loved spending time with them. He would tell anyone who would listen about all of their accomplishments.

John was a committed volunteer, not only to sports: VUMC he participated on many church council meetings, was an usher, MYF Leader, mentor for conformation, Vestal Lions Club, Vestal Booster Club, Inside Information Club, Vestal All-Nighter, and Soccer Booster Club. Reunion Update: BFReunion to BFZoom

After careful consideration, the Bradt leadership committee has decided not to hold an inperson reunion (BFR) in 2024.

But wait! Do not despair! In order to give those who still value personal relationships with their many "cousins" the opportunity to see each other, your Bradt leadership committee has come up with the idea of holding Zoom meetings. We held our first "practice" Zoom meeting in September and reviewed the viability of holding Zoom get-togethers for larger groups. We are still working through the details for our first Bradt Family Zoom (BFZ), but we know that many have always enjoyed the talks on various and sundry topics relating to Bradts and the history of New Netherland, so we will want to include those kinds of presentations over Zoom. (By the way, if any of our members with experience managing Zoom meetings would like to set up and run our BFZ, please contact any of your BFS leaders. We would rather have a family member running our Zoom meetings than some outside entity!)

One of the first things we will need is a good list of email addresses so we can notify members of the time and date of any BFZ. **Please send your current email address to:**

nextbfr@gmail.com. The emails will be consolidated and used when we start posting for our Zoom meetings, probably early in 2024.

The decision to cancel the 2024 Bradt Family Reunion was made in part from the feedback to our survey form included with the Spring BFN, to which we had a tepid response. Of the 15% who responded, barely 50% said they would attend. Considering this weak response, it was decided not to invest our time and money in a BFR that would most likely be poorly attended.

Other factors that were considered in our cancellation in 2024 include the rising costs in all areas for holding such a large-scale reunion: transportation, rooms, rental spaces, dinners, tour buses, tour venue fees, and taxes. A number of our members have also indicated that it would be difficult for them to travel to a reunion, and there are the obvious health concerns. Finally, we had to consider the dedicated volunteers who made our prior reunions possible, and they have also become harder to find. Many older and experienced local family members have passed, and our younger members have not yet come forward to take up the challenges of organizing and running a large event such as ours.

As you may be aware, the Bradt Family Society (BFS) has, over the past 36 years, contributed a great amount of research on the Bradt family in the New World since Albert and Arent first arrived at Fort Orange, New Netherlands on the dreary spring day of 8 April, 1637. As a result, we have been able to flesh out the lives of many of those early pioneers who struggled to find their places as they worked and raised families in this new land, and we have learned how they helped to shape the New World.

Numerous books have been published by our members, including genealogies by Cynthia Brott Biasca and Laurie Grimes, histories by Joan Woods and Peter Christoph, and historical fiction by Gloria Waldron Hukle. In addition, the Bradt Family News (BFN) has included stories of interest about family members past and present and has kept us abreast of new research and discoveries.
